WPC Resources

Members: more than anything else, the work of the coalition is made possible through the efforts of its members. Thank you for contributing your time, your valuable skills, and perspectives, and a shared passion for the youth in our community.

Grants: funding received through the grants helps support the coalition's efforts even further:

- Drug Free Communities Grant: *\$125,000 per year for up to ten years through the Office of National Drug Control Policy. (purpose: staff time, training, coalition capacity building, and coalition-directed strategies targeting youth substance abuse prevention). We are currently beginning year 8 of this grant.*
- County Prevention Grant: *\$215,620 through state legislation. (purpose: staff time, strategies targeting substance abuse, and suicide prevention) Grant renews every two years, we are currently in year two of grant.*
